## Parent Consent/WAIVER Form

As consideration for being allowed to participate and/or compete in the **YGJR** events, I the undersigned agree to the following:

**Dress Code Rules:** I have read and fully understand the Official YGJR Rule Book regarding dress code. I understand the YGJR Dress Code Rules and agree (for my child/children to abide by the Dress Code AT ALL TIMES upon entering the rodeo grounds. I understand that my child is to be in rodeo attire and if they enter the arena without rodeo attire as required it could result in disqualification in that event.

<u>Acknowledgement of Risk</u>: The undersigned acknowledges that the YGJR events are dangerous activities and that the participation in said events, as either a contestant, an employee, or volunteer, exposes the participant to a substantial and serious risk or property damage, personal injuries, or death. The undersigned expressly acknowledges that his/her participation will involve such hazard. <u>Release of Sponsors</u>: The undersigned being fully aware that participation in the YGJR events will expose him/her to a substantial and serious risk of property damage and/or personal injury or death, hereby releases all sponsors from liability for any and all property damage, personal injury or other claims arising from the undersigned's participation in said events including those that are known or unknown, foreseen and unforeseen, future or contingent.

<u>Covenant Not To Sue:</u> The undersigned covenants that the undersigned shall not now or at any time in the future, directly or indirectly, commence or prosecute any action, suit or other proceedings against the sponsors (or their officers, directors, employees, agents, volunteers, Hidden Springs Farms or affiliates) concerning arising out of, or related to the actions, causes or actions, claims and demands hereby waived, released or discharged by the undersigned. My signature shall be deemed a waiver of the right to bring an action against Released Parties.

<u>Assurance</u>: The undersigned has full power, authority, capacity and right without limitations to execute, deliver, and perform the release.

<u>**Rules:</u>** The undersigned agrees to all of the rules of the YGJR Rodeo. I understand that my child is responsible to raise \$300 in sponsorships or work the annual fundraiser in order to qualify for yearend awards.</u>

**<u>Binding Effect:</u>** This release shall be binding upon the undersigned and the undersigned's spouse, legal representative, heirs, successors, and assigns.

**Note:** Participants under 18 years of age must have the following signed by their parent or guardian. **Consent to Treat:** I hereby give the affiliated EMS the right to treat the above listed child, which I am the parent or guardian should the need arise.

## POINT SYSTEM CHANGE: The point system has changed for 2024.

<u>YEAR END AWARDS</u>: I understand that there must be a minimum of 10 entries in a class for it to qualify as a buckle/saddle event for year end. I understand that for my child to qualify for year-end awards, they must compete in at least 5 rodeos and participate at finals to qualify for year-end awards. I understand that to qualify for all around POINTS, my child must compete in at least 3 events and finals in at least 5 or more rodeos and finals. I understand that my child is required to participate in fundraising/requests for sponsorships. It is required that each child raise \$300 in sponsorships or work the annual fundraiser in order to qualify for yearend awards. All proceeds of sponsorship/fundraising go directly to yearend awards. I have read the above release in full. I totally understand its terms and conditions, and I hereby voluntarily execute and deliver this consent to contestant's participation in the YGJR events. I further agree to be fully bound by the release's terms and conditions both by individual capacity and in my capacity as parent or legal guardian of the contestant.
