I UNDERSTAND THAT WHOEVER LEADS A CHILD IN A LEADLINE EVENT IS ALSO REQUIRED TO BE IN RODEO ATTIRE. I ALSO UNDERSTAND THAT THIS DOES NOT INCLUDE PARENTS/FAMILY THAT ARE IN THE ARENA DURING THE BUCKAROO EVENTS. I UNDERSTAND THAT THEY ARE ALLOWED IN THE ARENA TO SUPPORT THE CHILDREN AS LONG AS THEY ARE NOT IN THE WAY OF THE JUDGES/STAFF.

Acknowledgement of Risk: The undersigned acknowledges that the YGJR events are dangerous activities and that the participation in said events, as either a contestant, an employee, or volunteer, exposes the participant to a substantial and serious risk or property damage, personal injuries, or death. The undersigned expressly acknowledges that his/her participation will involve such hazard. Release of Sponsors: The undersigned being fully aware that participation in the YGJR events will expose him/her to a substantial and serious risk of property damage and/or personal injury or death, hereby releases all sponsors from liability for any and all property damage, personal injury or other claims arising from the undersigned's participation in said events including those that are known or unknown, foreseen and unforeseen, future or contingent.

<u>Covenant Not To Sue:</u> The undersigned covenants that the undersigned shall not now or at any time in the future, directly or indirectly, commence or prosecute any action, suit or other proceedings against the sponsors (or their officers, directors, employees, agents, volunteers, Hidden Springs Farms or affiliates) concerning arising out of, or related to the actions, causes or actions, claims and demands hereby waived, released or discharged by the undersigned. My signature shall be deemed a waiver of the right to bring an action against Released Parties.

I understand that for my child to qualify for year-end awards, they must compete in at least 3 rodeos and participate at finals to qualify for year-end awards. I understand that to qualify for all around, my child must compete in at least 3 events and finals. I understand that my child is required to participate in fundraising/requests for sponsorships. It is required that each child raise \$300 in sponsorships to qualify for yearend awards. All proceeds of sponsorship/fundraising go directly to yearend awards.
